
Pretreatment

The reveal must be cleaned of dirt and mortar residues


Important information

The expansion behaviour of the tape depends on the joint and ambient temperature. At higher temperatures, the tape expands relatively quickly and must be used quickly. Therefore, storage of the tape at temperatures above + 20 °C or directly in the sun for a longer period of time should be avoided. The tape should also be stored in a cool place on the construction site. At lower temperatures, we recommend storing the material at approx. + 20 °C for at least 24 hours before application. The expansion of the built-in tapes can be accelerated by heating. At temperatures below + 8 °C, the tape should also be kept at room temperature on site to avoid delays in the expansion of the installed tapes. EMICODE® is a registered trademark of GEV e. V. 
Processing information




Step 1: Determination of the joint width and the joint area. To do this, measure the masonry opening and window frame. The masonry must have a smooth finish and the resulting joint width must match the joint area of the selected multifunctional sealing tape all around.




Step 2: Cleaning the window frame and reveal from dirt, dust or other impurities.




Step 3: Stick the OTTOTAPE Trio-BKA MF1 on the top of the frame. Here the tape is to be cut to the exact length of the top of the frame.



Step 4: Stick OTTOTAPE Trio-BKA MF1 onto the lintel and the balustrade, leaving a small lateral overhang (adhesive joint). Cutting out/adjusting the tape at the window connection joint or other substructure profiles.



Step 5: Use OTTOTAPE Trio-FBA for the window connection joint and stick it on.



Step 6: Place the window frame into the opening, adjust and fasten.

Application information

OTTOTAPE Trio-BKA MF1 replaces three sealing products in the window connection joint with one product, provided the joint width is within the expansion range of the tape, whereby joint widths of 5 to 20 mm can be covered with only three tape dimensions. The remaining joint width is determined by measuring the window frames and the reveal opening. This is necessary in order to select the correct tape dimension and to determine the necessary projection for the cuts on the lintel and on the two sides. Cut open the wrapped liner of the tape, unroll and store for resealing if necessary. Then cut off the first 5 cm of the tape and discard. Now stick the tape to the window frame without pulling. Make sure that the tape is positioned correctly (the inside of the room is the side where the tape is printed).

Due to the many possible influences during and after application, the customer always has to carry out trials first.
